The new law restricts each phthalate to no more than 0.1% in each homogeneous material of an electrical product.

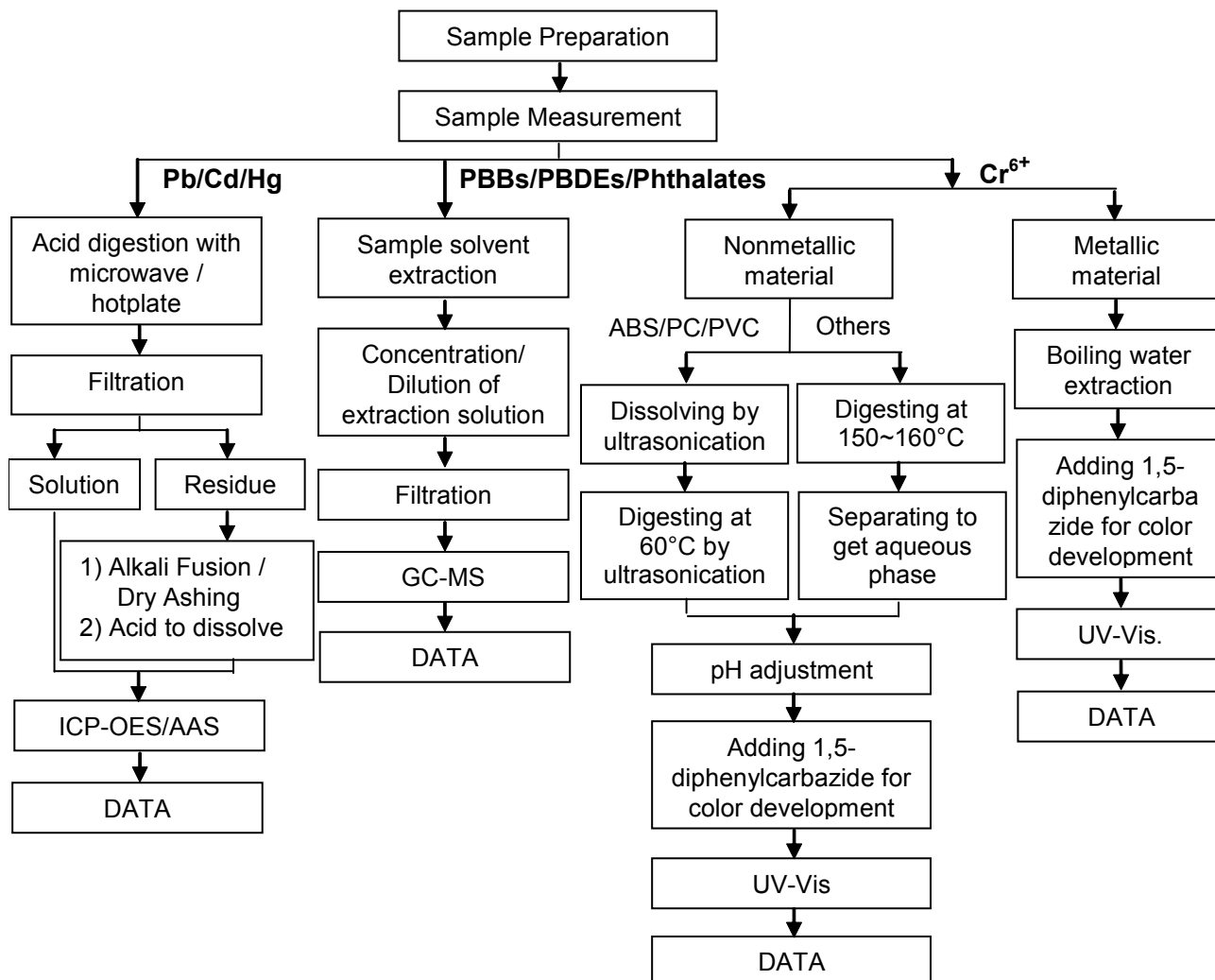

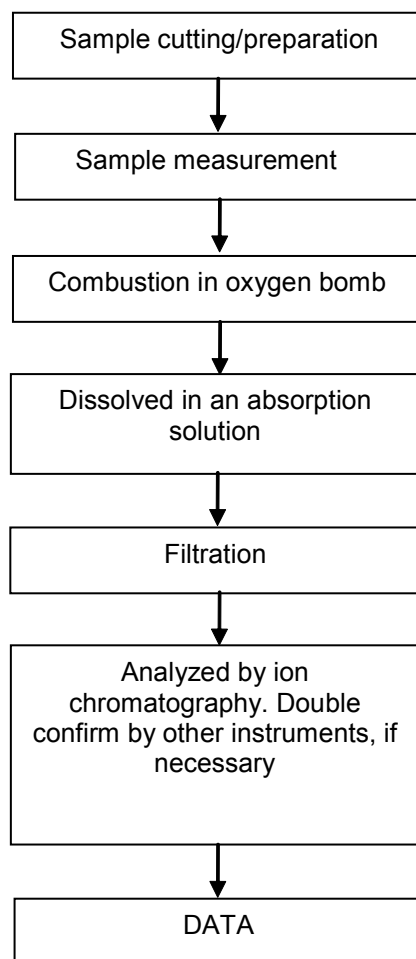

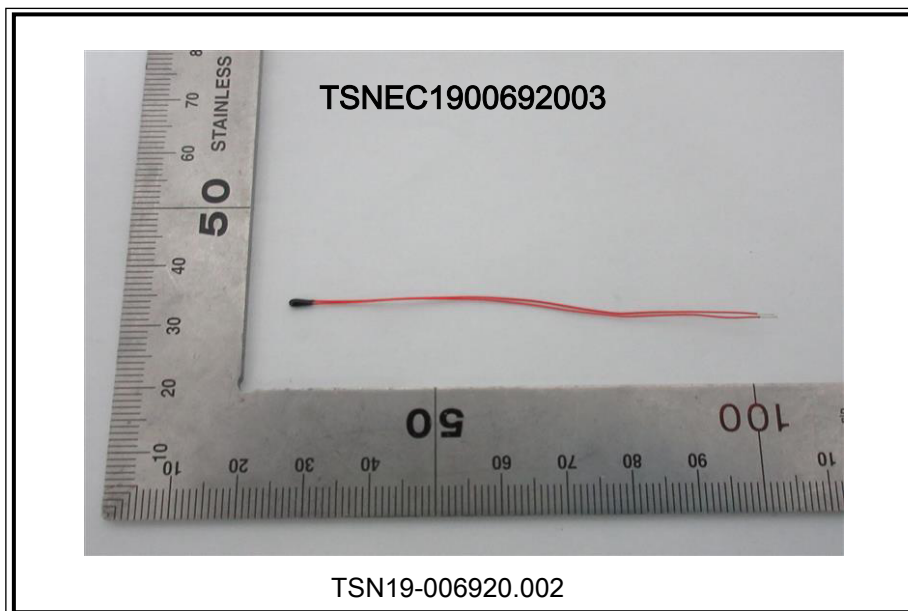
